Unfortunately, there is a lack of cohesion within this year's convention committee. There is a blatant disregard for policy and administrative direction and an apparent lack of unity amongst committee members. Our groups need to know and understand how your donations are being spent to fund the convention and have input on the events being planned. Our groups need to support the primary purpose which is to bring our membership together in the celebration of recovery and to carry the message of recovery to the addicts who still suffer. Our groups are the most powerful vehicle in helping us to accomplish this purpose.

Policy: Two attendees for April Subcommittee meeting. Per biannual revisions of policy, we'll be working on updates to manual over the next month and copies will be available at June Area Service Meeting. Finally, it was brought to me via a subcommittee's trusted servant that this subcommittee's policy states that the decision making process operates under Robert's Rules of order (page 11).
