Convention Committee: Account balance is \$11,498.56. Registrations sold to date: 329. Registrations are \$20 until 9/2/18 and increase to \$25 after. Sold at area for \$5 discount.

Policy: 6 people were in attendance at this month’s subcommittee meeting, leading to a total of 3 motions to be presented to area pertaining to Delaware County policy. 1 motion applying to the conduct of trusted servants reads as follows: “We are presenting a motion to adopt this article from region and place into Area Policy in Article VII, which appears prior to ‘Qualifications of ASC Officers’”. The other 2 motions pertain to the motion making process. Since we didn’t have time to discuss the full breadth of the suggested revisions to policy from last month, we will be meeting Sept 12 at 6PM at Riverview Church in Drexel Hill to review and discuss. All are welcome to attend. Thanks for allowing me to serve.

H&I: Almost all the commitments are filled. Monday night Keystone for the men just opened up until the end of September if anyone wants to fill it. We had to let the prison go. **** To be voted on by home groups****

Group: HOW Group

Motion: Remove Area Co-Chair from his position.

Intent: To maintain an environment of recovery.

Subcommittee: Policy

Motion: All motions at DC ASC meetings are to have 2 prefixes, “to go back to groups” or “to be voted on at area”. Currently, all motions, except those to fill sudden subcommittee vacancies, are to go back to groups.

Intent: To bring practicality to area. To prevent weighing down home groups with matters that do not impact home groups, or NA as a whole, but instead apply solely to ASC meeting.

Subcommittee: Policy

Motion: To adopt Article X (Conduct of Trusted Servants) from regional policy to Delaware County Area Policy as Article VII (prior to Qualifications of ASC Officers).

“ARTICLE X CONDUCT OF TRUSTED SERVANTS

A. The purpose of this article is to keep an atmosphere of love, understanding, and respect and to uphold the principles of the Twelve Steps, Twelve Traditions and Twelve Concepts.

B. The following will not be tolerated during the RSC meeting:

1. continued meeting disruption (i.e. whispering, outbursts, side conversations)

2. speaking without being recognized

3. use of abusive language toward other individuals or the body as a whole

4. use of personal threats toward other individuals or the body as a whole

5. intentional or reckless false accusations or unwarranted attacks on the character of individual members or the body as a whole

C. If such actions occur the Chair shall issue one (1) warning. If there is a reoccurrence by the same individual that individual will be asked to leave the meeting. Repeat violations over more than one meeting may, at the will of the RCM’s, be considered grounds for removal from office.

D. Any acts of physical violence committed on regional property will not be tolerated and shall be handled by the appropriate authorities with which the RSC and the GPRS, Inc shall cooperate fully. If the act is committed by an RSC trusted servant this shall be, at the will of the RCM’s, grounds for removal from office.”

Intent: To bring and keep order and keep the atmosphere of recovery present at ASC meetings and to provide clear expectations of behavior.
