Sold: 741 registrations, 110 rooms, 80 dinners, 52 breakfasts, 107 comedy tickets, 59 newcomer packets, 12 indigent packages. Our bank balance as of 10/11: \$18,427.74 – \$323.05 (American mkt) + \$55.00 (owed to us for shirts) = \$18,159.69 - \$15,000.00 remains in bank = \$3,159.69 area donation. Thanks for your support and thanks for letting me serve!

**Policy:** 6 here in attendance at this month’s policy subcommittee meeting. We reviewed the verbiage in the “Conduct of Trusted Servants” motion that was rescinded last month.
